RESOLUTION 2016-22

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE BAINBRIDGE ISLAND METROPOLITAN PARK & RECREATION DISTRICT, KITSAP COUNTY, WASHINGTON, ADOPTING AN AMENDED GENERAL FUND BUDGET FOR THE FISCAL YEAR 2016.

WHEREAS, the Commissioners of the Bainbridge Island Metropolitan Park & Recreation District adopted the General Fund Budget for fiscal year 2016 in Resolution 2015-16 on November 5, 2015, and amended it in Resolution 2016-13 on June 16, 2016; and

WHEREAS, the aforementioned 2016 General Fund Budget must now be revised again to include:

- 1) An interfund transfer in the amount of \$223,736.68 from the General Fund to the Capital Improvement Fund related to the Rotary Park Renovation Project as approved by the Board of Commissioners in Resolution 2016-20 on October 20, 2016; and
- 2) An interfund transfer in the amount of \$9806.00 from the General Fund to the Capital Improvement Fund related to purchasing a new boiler for the Ray Williamson Pool as previously agreed to by motion at the July 7, 2016 board meeting; and

WHEREAS, these revisions are included and specified in the attached Amended 2016 General Fund Budget,

NOW THEREFORE BE IT RESOLVED by the Board of Commissioners of the Bainbridge Island Metropolitan Park & Recreation District, Kitsap County, Washington, that the General Fund Budget for the fiscal year 2016 be amended as indicated above, and that this amended budget is attached hereto as Exhibit "A", and incorporated by reference in its entirety, be and the same are hereby adopted and ratified.
