<u>Recreation Services Director</u>: John DeMeyer: the pond at Battle Point Park is getting stocked with fish tomorrow in time for Outdoor Program fishing events; the summer brochure is going to print next week and is the biggest ever; the website committee met recently with a consultant who will fix any technical glitches the revamped website might need prior to being launched. The lowest of three bids for a new boiler at the Aquatics Center Nakata pool was accepted last week; the new boiler was installed and operating by Saturday afternoon.

<u>Senior Planner</u>: Perry Barrett: provided an update on the Hidden Cove Park Dock permitting process saying he recently met with DNR reps at the site.

<u>Park Services Superintendent</u>: Mike Mejia: Earth day is on April 26 and work is being lined up for volunteers at Pritchard Park; the drains at Fort Ward Park are cleaned out; mowing season has begun; the trees at Ted Olson Nature Preserve and Fay Bainbridge Park were assessed recently when a DNR representative was on the island.

Executive Director: Terry Lande: had a good meeting recently with City Manager Doug Schulze during which they covered a number of topics including storm water management fees, permits, Hawley Cove, dog codes and leash laws, the Meigs transfer, management of Pritchard Park, the Lovgren pit, and a new direction for IGWG. He is meeting with Deputy City Manager Morgan Smith next week to discuss property transfers. He will meet Monday with Sally Maron to discuss the artisan's BARN project.
