A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE BAINBRIDGE ISLAND METROPOLITAN PARK & RECREATION DISTRICT, KITSAP COUNTY, WASHINGTON, ADOPTING AN AMENDED LAND ACQUISITION FUND BUDGET FOR THE FISCAL YEAR 2012.

WHEREAS, the Commissioners of the Bainbridge Island Metropolitan Park & Recreation District adopted Resolution 2011-18 on November 17, 2011 adopting the Land Acquisition Fund Budget for fiscal year 2012; and

WHEREAS, the 2012 Land Acquisition Fund Budget must now be revised to reflect the following:

- 1. 2011 carry forward amounts resulting from land acquisition expenses anticipated in 2011 but incurred in 2012 when the land transactions closed;
- 2. Resolution 2012-10 that authorized an interfund loan from the Park District's General Fund to the Land Acquisition Fund in the amount of \$150,000 in order to cover land acquisition costs until delinquent property tax revenues come in;
- 3. Washington State RCO grant funds anticipated in 2011 that were received or will be received in 2012;
- 4. Allocation of funds for trail easements in 2012, and

WHEREAS, the above changes and revisions are specified in the attached Amended 2012 Land Acquisition Fund Budget,

NOW THEREFORE BE IT RESOLVED by the Board of Commissioners of the Bainbridge Island Metropolitan Park & Recreation District, Kitsap County, Washington, that the Land Acquisition Fund Budget for the fiscal year 2012 be amended as indicated above, and that this amended budget is attached hereto as Exhibit "A", and incorporated by reference in its entirety, be and the same are hereby adopted and ratified.
