WHEREAS, it is understood that as additional policies are drafted or existing policies are revised, they will be brought to the Board for review, adoption, and inclusion in the District's Policy Manual; and

WHEREAS, the following has been prepared by staff, reviewed by the Board of Commissioners in first and second readings, and are ready to be adopted for inclusion in the District's Policy Manual:

- 1. New operational policies: Volunteers, Concession Operations, Petty Cash and Change Funds, Small and Attractive Assets,
- 2. Revision of existing policy: Risk Management (prev. adopted, Res 2010-25, 12/16/10);
- 3. Reformat existing policy: Naming Parks and Park Facilities (prev. adopted, Res. 2000-07, 9/14/00)

NOW THEREFORE BE IT RESOLVED by the Board of Commissioners of the Bainbridge Island Metropolitan Park & Recreation District, Kitsap County, Washington, that the above operational policy additions/revision/reformat be approved and included in the Park District's Policy Manual:
