A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE BAINBRIDGE ISLAND METROPOLITAN PARK & RECREATION DISTRICT, KITSAP COUNTY, WASHINGTON, IN HONOR OF EMPLOYEE JANE ALLAN AND HER MANY YEARS OF SERVICE TO THE PARK DISTRICT AND BAINBRIDGE ISLAND SENIOR COMMUNITY CENTER.

WHEREAS, Jane Allan began employment at the Senior Center with the Bainbridge Island Park & Recreation District on March 1, 1999, and has served as Park District Program Coordinator II with responsibility to direct the Senior Center's programs, activities, and operations since December 12, 2002; and

WHEREAS, she retired from her position with the Park District on September 30, 2012; and

WHEREAS, she spent countless hours developing a robust array of activities and programs for Bainbridge Island seniors to stay active; and

WHEREAS, she energized and originated many clubs to involve seniors in activities such as the Bicycle Club, Soft Ball program, and Laughter Yoga Club; and

WHEREAS, she played a key role in the transition of Senior Programs to 50 Plus Programs; and

WHEREAS, she was successful in identifying and coordinating resources that provide assistance to frail seniors with life transitions; and

WHEREAS, she played a key role while working with partner organizations including the Senior Center Nonprofit and the City of Bainbridge Island to develop a Strategic Plan for the Senior Center, and ultimately promoted the use of available resources to successfully remodel and reconstruct the existing facility in a manner that will benefit the entire community for years to come; and

WHEREAS, through these efforts she successfully united the three facilities known as the Senior Center, the Bainbridge Commons, and the Health District under a single comprehensively managed facility better suited to serve the community; and

WHEREAS, because of her enthusiasm, dedication and commitment to the seniors of Bainbridge Island, she has enriched countless lives and endeared herself to the community,

NOW THEREFORE BE IT RESOLVED by the Board of Commissioners of the Bainbridge Island Metropolitan Park & Recreation District, Kitsap County, Washington, that Jane Allan be commended for her outstanding years of service to the Park District and the community of Bainbridge Island.
